Rules:

1. Participants may start collecting pledges as soon as they receive the pledge sheets. **Reminder: Pledge sheets need to be turned in on walk-a-thon day, Saturday, February 11, 2012.**
2. Pledges may be made by anyone. However, participants may not ask for pledges from any of the staff members of Orlando Day Nursery or The Salvation Army. **Please ask everyone who pledges if their company has a matching gift fund policy.**
3. **Each sponsor making a pledge should write their own name, pledge per lap, and maximum pledge.** Participants may collect the pledge in advance.
4. On walk-a-thon day, each participant will walk during the allocated time around Lake Dot. Each lap is approximately 1/3 mile. Each participant will be responsible for keeping track of the number of laps he/she has completed.
5. Upon completion of the walk-a-thon, participants will hand in their lap report. A volunteer will record each participant's lap total on their pledge sheet and return it. Participants may then collect outstanding pledges. **Please return pledge sheets with the money to Orlando Day Nursery by Wednesday, February 29, 2012. Make checks and money orders out to Orlando Day Nursery.**
6. No running or jogging will be allowed. Participants are encouraged to wear hats and sunscreen if it's sunny or bring rain gear if it's rainy.

WAIVER AND RELEASE (ONE FORM PER PARTICIPANT)

Homelessness to Hope 2012 Walk-A-Thon

1. I wish to participate in the Homelessness to Hope 2012 Walk-A-Thon. I understand that my execution of this Waiver and Release is a prerequisite for participation in the event.

2. I agree to accept all risks associated with this event including but not limited to falls, contact with other participants, the effects of weather including possible high heat and humidity, the condition of the roads and traffic, all such risks being known to and appreciated by me.

3. Knowing these facts, and in consideration of your accepting my entry for this event, I hereby, for myself, my heirs, executors, administrators, or anyone else who might claim on my behalf, covenant not to sue, and waive, release and discharge Orlando Day Nursery Association, Inc., The Salvation Army of Orange and Osceola Counties, City of Orlando, and all of their officers, agents and employees, and authorized volunteers, with respect to any and all claims for damages for death, personal injury or property damage which I may have, or which may hereafter accrue to me as a result of my participation in the Homelessness to Hope 2012 Walk-A-Thon, even though this liability may arise from negligence or carelessness on the part of the persons or entities referred to in this paragraph or from dangerous or defective property or equipment owned, maintained, or controlled by any such person or entity.

4. I understand that I am solely responsible for my health and safety and that the course which participants will be walking will be, for the most part, unsupervised. I acknowledge that I am physically capable of safely participating in and completing this event. If I am a parent or guardian signing on behalf of a person who is less than 18 years of age, I acknowledge that I am strongly encouraged to personally accompany and provide adult supervision for such person during the entire event.

5. I agree to allow Orlando Day Nursery Association, Inc., The Salvation Army of Orange and Osceola Counties and their contractors, agencies and sponsors, the use of my name, photo and likeness in connection with the event for any purpose related to advertising or promotion of the Event worldwide in perpetuity in all forms of media now and forever known.

6. Should any portion of this Waiver and Release be judicially determined to be invalid, violable, or unenforceable, for any reason, such portion of this Waiver and Release shall be severable from the remaining portions herein and the invalidity, voidability, or unenforceability thereof shall not affect the validity, effect, enforceability, or interpretation of the remaining provisions of this Waiver and Release.

7. I have carefully read this Waiver and Release and fully understand its contents. If I am under 18 years of age at the time of registration, my parent or legal guardian has completely reviewed this Waiver and Release and understands and consents to its terms, and authorizes my participation by his/her signature below. I am aware that this is a RELEASE OF LIABILITY and a contract between me and the persons and entities mentioned above and I sign of my own free will.
